SUPREME COURT JUSTICE MARY JANE THEIS ANNOUNCES JUDICIAL SCREENING COMMITTEE

Supreme Court Justice Mary Jane Theis announced Friday the formation of a bipartisan screening committee to assist her in selecting Circuit Court judges for appointment to fill interim vacancies on the Cook County Circuit Court.

The screening committee will be made up of 13 lawyers and one non-lawyer and will be co-chaired by retired U.S. District Court Judge Wayne R. Andersen and retired Illinois Appellate Court Judge Michael J. Gallagher.

Under the Illinois Constitution, the Supreme Court has the authority to fill judicial vacancies by interim appointment until they are filled for the full term by voters' choice in the next election. Traditionally, the three justices from the First Judicial District in Cook County rotate in recommending a candidate to the Court for the appointment.

The committee is expected to screen applicants for judgeships after the candidates have been evaluated by bar associations. The committee then will forward recommendations to Justice Theis.

"The committee is composed of top-notch people—diverse and highly qualified," said Justice Theis. "I thank them in advance for their willingness to serve and help me discharge a very important, constitutional duty. I am sure their dedication and insight will be invaluable to me."

How the committee proceeds will be left up to its own organization, said Justice Theis.

Judge Andersen, who serves as co-chair, also is a member of a statewide judicial review commission to aid U.S. Sen. Mark Kirk (R-Ill.) in working with senior Democratic Sen. Dick Durbin forwarding names to the President for nomination to the U.S. District Court.

"Among the criteria the Committee will look at in candidates are legal experience, integrity, professional competence, judicial temperament and a commitment to justice," said Judge Andersen. "In short, the committee will be looking for judicial candidates with smart minds, good hearts and a life experience that shows empathy for everybody in our community."

Judge Gallagher said, "This is a panel composed of persons with diverse experience and outstanding talent. I look forward to working with Judge Andersen and all of the committee members in helping Justice Theis nominate strong candidates for the bench."

The committee members and their backgrounds are:

The Hon. Wayne R. Andersen (ret.) Judge Andersen has served as a U.S. District Court judge for the Northern District of Illinois for 19 years, retiring in 2010. Before that, he served as a Cook County Circuit judge for seven years. Known for his superb people skills and exceptional legal knowledge, Judge Andersen presided over thousands of cases while serving in the federal and state judiciary, and settled many of them. One of the most widely known is the Shakman litigation, brought to eliminate illegal political patronage practices encompassing tens of thousands of employees for the City of Chicago and the County of Cook. He currently works in Chicago as an alternative dispute resolution specialist with JAMS, a nationwide dispute resolution firm. He is the recipient of numerous honors, including the prestigious Justice John Paul Stevens Award for his commitment to integrity and public service, presented by the Chicago Bar Foundation and the Chicago Bar Association. He received his B.A. *cum laude* from Harvard University and his J.D. from the University of Illinois College of Law.

The Hon. Michael J. Gallagher (ret.) Judge Gallagher served as an Illinois Appellate Court justice in the First Judicial District (Cook County) from 1996 until his retirement in 2011 and was chairman of the Executive Committee. Before the Appellate Court, Judge Gallagher served as a Cook County Circuit Judge from 1988 to 1996; and in the Law Division he successfully mediated settlements in many complex cases in diverse areas of the law. He consistently received the highest evaluations from bar associations throughout his judicial career, and was a frequent faculty presenter at educational programs and seminars for judges. He founded, owns and is currently active with Michael J. Gallagher Mediation Services LLC in Chicago. Judge Gallagher also has served as an adjunct faculty member at The John Marshall Law School.

The Hon. David H. Coar (ret.) Judge Coar served as a U.S. District Court judge for the Northern District of Illinois for 16 years until his retirement in 2010. He also served as a U.S. Bankruptcy Judge for the Northern District of Illinois from 1986 to 1994 and as the first U.S. Bankruptcy trustee in the Northern District from 1979 to 1982 under a pilot program of the Justice Department. He has experience in hundreds of cases involving complex matters, including multi-district class action litigation and an asbestos bankruptcy case that involved the resolution of claims totaling over \$92 billion. He has traveled extensively around the globe, consulting on judicial and economic issues and has participated in various education programs overseas for foreign judges. He is a former associate dean and associate professor of law at DePaul University College of Law, is an arbitration specialist with JAMS, and served in the Marine Corps and Marine Corps Reserves from 1965 to 1971. He received his J.D. from Loyola University Chicago School of Law and his LL.M from Harvard Law School.

Alison C. Conlon Ms. Conlon is a partner in the Chicago office of Barnes & Thornburg and is the co-chair of the firm's commercial litigation practice group. She focuses her practice on commercial disputes, construction cases, toxic tort cases, professional malpractice issues and other matters for companies, municipalities and individuals. She serves on the Board of Managers of the Chicago Bar Association and was appointed by the Illinois Supreme Court to the Hearing Board of the Illinois Attorney Registration and Disciplinary Commission. She earned her B.A. *cum laude* in English from Yale University, an M.A. in English from Georgetown University and her J.D. *magna cum laude*, from Duke University in 2000. She began her legal career as a law clerk for U.S. District Judge Charles P. Kocoras in the Northern District of Illinois.

Mary A. Dempsey Ms. Dempsey serves as president of the Philip H. Corboy Foundation. The foundation's mission is to support education, social justice, access to the courts, preserving the rights of the disabled, and arts and culture. From 1994 to 2012, she served as commissioner of the Chicago Public Library, being appointed by former Mayor Richard M. Daley and reappointed by Mayor Rahm Emanuel. Under her direction, 44 new libraries were constructed in Chicago with state-of-the-art technology. . From 1982 to 1993, Ms. Dempsey practiced law in Chicago, concentrating in the areas of health law, land use and legislative counseling. She received her J.D. degree from DePaul University, and is a past chair and current member of the Board of Trustees of DePaul University. Denise Kane Ms. Kane serves as Inspector General for the Illinois Department of Children and Family Services. With a lifetime of community and public service, she was the first person appointed to that position in 1993 by Gov. Jim Edgar, and has held it ever since. Ms. Kane began her career as a teacher at St. Michael's High School in Chicago; was a probation officer in the Juvenile Court of Cook County; director of operations at Association House of Chicago; administrator at the juvenile division of the Cook County Public Guardian's Office; and associate director of the Citizens Committee of Cook County Juvenile Court. While there, Ms. Kane designed and participated in a nonviolence training program for youth awaiting trial in the adult criminal court. In 1987, while with the Public Guardian's office serving as director of social services, she was instrumental in the federal litigation resulting in the "Norman Decree", a case that prohibits children from being removed from their homes due to poverty issues. She also provided expert testimony in litigation result in the Hill Decree, which recognized the rights of teen parents. Ms. Kane received both her M.A. and Ph.D. from the University of Chicago.

Elizabeth A. Kaveny Ms. Kaveny is a partner with the Chicago law firm of Burke Wise Morrissey & Kaveny and one of a few women to become a name partner in a high profile plaintiff's trial lawyer firm. Before her career in academics, Ms. Soliunas was in-house counsel for the former Bell System for more than 20 years. Prior to that, she spent eight years in government service: as a supervisory trial attorney for the Equal Employment Opportunity Commission and a state appellate defender for the Illinois State Appellate Defender Prison Legal Services Project.
